- DAISY textbooks are only intended for educational use by children and students who have difficulty reading ordinary printed textbooks. Please manage downloaded textbook data and the systems used to view it to ensure that they are not used for purposes other than the intended purpose.
- Usage requests may be submitted by textbook users (if the textbook user is a minor, then the consent
 of their parent or guardian is also required), parents or guardians, teachers, special needs education
 coordinators, school board members, and support personnel. If you have any questions, please
 contact the Japanese Society for Rehabilitation of Persons with Disabilities.
- Usage of the DAISY textbook data made available via the provision system is permitted under Article
 37, Paragraph 3 of the Copyright Act. Unauthorized reproduction or transfer to a third party is prohibited.
- A separate usage request must be submitted each academic year. At the end of the academic year for which a request was issued, the user of the DAISY textbook data is responsible for deleting the data.
- Please responsibly manage the login names, passwords, and other information provided for DAISY textbook usage purposes and prevent them from being leaked to third parties. If you discover that a login name and password have been leaked or used by a third party, immediately contact the Japanese Society for Rehabilitation of Persons with Disabilities and follow any and all instructions.
- If you are deemed to have used the DAISY textbooks or system inappropriately, your usage permissions will be terminated immediately. In the event of damages caused by violations of copyright, violators will be responsible for paying said damages.

Usage Notes

- Except for textbooks supplied via CDs, DAISY textbooks can be used free of charge. However, users will be responsible for providing, at their own expense, any network environment, tablet computers, playback software, etc., necessary for viewing the DAISY textbooks.
- DAISY textbooks are produced and provided on consignment by the Ministry of Education, Culture,



Sports, Science and Technology, so users may be asked to respond to questionnaires, report on usage conditions, assist with school tours (we will consult with you separately in the event of school tours), and permit the inclusion of information regarding usage conditions, etc. in project reports and on the Japanese Society for Rehabilitation of Persons with Disabilities website. Personal Information Protection Policy

The Japanese Society for Rehabilitation of Persons with Disabilities Information Center (hereinafter "the Society") will only use personal information submitted during DAISY textbook user registration for the following purposes, and will not use this information for any other purposes.

- Reporting to the Ministry of Education, Culture, Sports, Science and Technology the names of the schools attended by the students to whom DAISY textbooks have been supplied, the grades the students are in, the subjects for which the textbooks will be used, and the publishers of the textbooks, in accordance with the Act on Promotion of Distribution of Specified Books, etc. Used as Textbooks for Disabled Children and Students
- · The operation and management of the system for providing DAISY textbooks
- The distribution of questionnaires to users regarding their usage conditions and the collection of questionnaire responses from users
- Personal information may be used to send emails, etc., with information regarding services, seminars, and the like that could be of benefit to users. If you do not wish to receive this information, please contact the Society.
