- Populous country 160 M +
- 40% children <15 y about 65 M
- Growth Rate ~ 2.6%
- Disability ~ 2.5% of population
- Prevalence of Blindness 0.9%
- Low Vision 0.8%

BACKGROUND

- Plethora of development priorities
- Social protection issues
- Economic and sustainable livelihoods
- Water and sanitation
- Increased enrolment in primary education
- Health promotion, disease prevention

PARADOX

 Development organizations – have little knowledge and expertise on disability issues

 Disability organizations – tend to work in compartments with little understanding of development



MAINSTREAMING DISABILITY

- Main objectives of Sightsavers work in Pakistan:
 - Advocacy for policy change
 - Organizational strengthening and institutional development
 - Public awareness on Disability Issues

PUBLIC POLICY

- Pilot demonstration projects undertaken with Federal Directorate of Education and Directorate General of Special Education
- Promote Inclusive Education and Rehabilitation services for People with Disability

PUBLIC POLICY AND ADVOCACY



INSTITUTIONAL AND ORGANIZATIONAL DEVELOPMENT

- Two leading DPOs (STEP and Milestone) identified as champions – programmes include leadership development, soft skills for independent living and accessibility
- Learning visit to CDD in Bangladesh adopted and adapted CAHD model for mainstreaming
