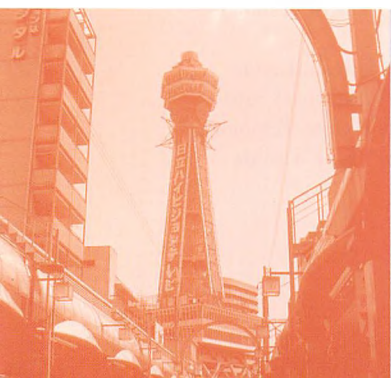
Dear colleagues, friends, ladies and gentlemen,

The Asian and Pacific Decade of Disabled Persons

Following the International Year of Disabled Persons (IYDP) in 1981 and the United Nations Decade of Disabled Persons in 1983-1992, the United Nations Economic and Social Commission for Asia and the Pacific (ESCAP), at its 48th session in Beijing, 1992, declared the period 1993-2002 as the Asian and Pacific Decade of Disabled Persons. It also decided the Agenda for Action for the Asian and Pacific Decade consisting of the 12 most urgent tasks to be addressed over the decade.

During this Decade many efforts, both governmental and non-governmental, have been made in the Asian and Pacific region to promote and ensure the human rights, full participation and equality of people with disabilities.

One of the most outstanding non-governmental activities in the Asian and Pacific Decade was a series of regional campaigns organized annually by the Regional NGO Network for the Promotion of the Asian and Pacific Decade of Disabled Persons (RNN). It started in Urazoe City, Okinawa, Japan in 1993 and has moved to different cities around the region, as outlined below. It has been highly successful in raising public awareness of, and mobilizing support for, the goals of the Decade.

OSAKA FORUM

The Asian and Pacific Decade of Disabled Persons ends in 2002 and a new era will usher in the renewal and further development of activities by and on behalf of people with disabilities in the region.

The International Forum on Disabilities to Mark the End Year of the Asian and Pacific Decade of Disabled Persons will be held in Japan in October, 2002. Its purpose is to provide a regional forum to review the actions for the implementation of the Agenda for Action for the Asian and Pacific Decade, to discuss regional achievements in the campaign for full participation and equality of people with disabilities, and to propose regional initiatives and directions for the follow-up activities after the decade's conclusion.

The Osaka Forum is one of two main events of this international forum and includes four international as well as national meetings; the other main event being the Sapporo Forum held in conjunction with the 6th Disabled Peoples' International (DPI) World Assembly.

The Osaka Forum consists of the 12th Rehabilitation International Asia and the Pacific Regional Conference (RI), the Campaign 2002 to Promote the Asian and Pacific Decade of Disabled Persons (RNN), the National Rehabilitation Conference (NR) and the International Research Meeting on Vocational Rehabilitation (VR).

Osaka Forum Meetings

The 12th Rehabilitation International Asia and the Pacific Regional Conference (RI)

The 12th Rehabilitation International Asia and the Pacific Regional Conference (RI) is the second RI Regional Conference held in Japan since this country hosted the 3rd Regional Conference in Tokyo in 1965. It was the first international conference held in Japan in the rehabilitation field since the end of the World War II, and had a strong impact on development, in Japan as well as in the region, of activities aimed at the rehabilitation and well-being of people with disabilities. The main purpose of the 12th RI Asia and the Pacific Regional Conference, as symbolized by its theme "Partnerships for Disability Rights", is the establishment of a UN Convention on the Rights of Persons with Disabilities in close collaboration with major international organizations of people with disabilities including Disabled Peoples' International, Inclusion International, World Blind Union, World Federation of the Deaf, World Federation of the Deafblind and World Network of Users and Survivors of Psychiatry.

The Campaign 2002 to Promote the Asian and Pacific Decade of Disabled Persons (RNN)

THE REGIONAL NGO NETWORK FOR THE PROMOTION OF THE ASIAN AND PACIFIC DECADE OF DISABLED PERSONS (RNN) was established in Japan on October 19, 1993, as a result of a resolution passed at the Campaign '93 of the Asian and Pacific Decade of Disabled Persons Regional NGO Conference in Okinawa. RNN's mission is the active promotion of the A/P Decade aiming at concrete achievements.

Its main function is:

- to enhance the linkage among NGOs
- to encourage and support NGOs and UN agencies in implementing the Agenda for Action for the A/P Decade
- to promote cooperation among NGOs
- to create and enhance public awareness of the Decade at all levels in the region

The 25th National Rehabilitation Conference (NR)

The Conference started in 1977 as a nation-wide meeting of professionals working in various fields of rehabilitation. Its mission is the total rehabilitation of people with disabilities. It has since been held annually at different venues across Japan and has provided a forum for a wide range of professionals and persons with disabilities to meet and discuss how to build comprehensive rehabilitation services and systems. It has also created the opportunity for participants to exchange their views and experiences. This year, to commemorate the final year of the A/P Decade of Disabled Persons, the National Rehabilitation Conference invites both RI and RNN participants to join in discussion on various topics of common interest. English interpretation is provided. They are also invited to join in a technical site visit to Universal Studios Japan (USJ), a famous theme park that is unique in its barrier-free environment and employment of many people with disabilities.

International Research Meeting on Vocational Rehabilitation (VR)

The Japan Association for Employment of Persons with Disabilities (JAED) implements the government measures stipulated by the Ministry of Health, Labor and Welfare, by providing various services in cooperation with the relevant organizations and employers. Among other projects, JAED has conducted an annual research meeting on vocational rehabilitation and employment of persons with disabilities since 1991, serving Japanese researchers, vocational counselors, specialists of relevant organizations, employers and personnel of public employment offices. This year, to commemorate the final year of the Asian and Pacific Decade of Disabled Persons, JAED is inviting overseas speakers to provide an opportunity for Japanese and overseas researchers, specialists, employers and policymakers to network among participants on an international scale.

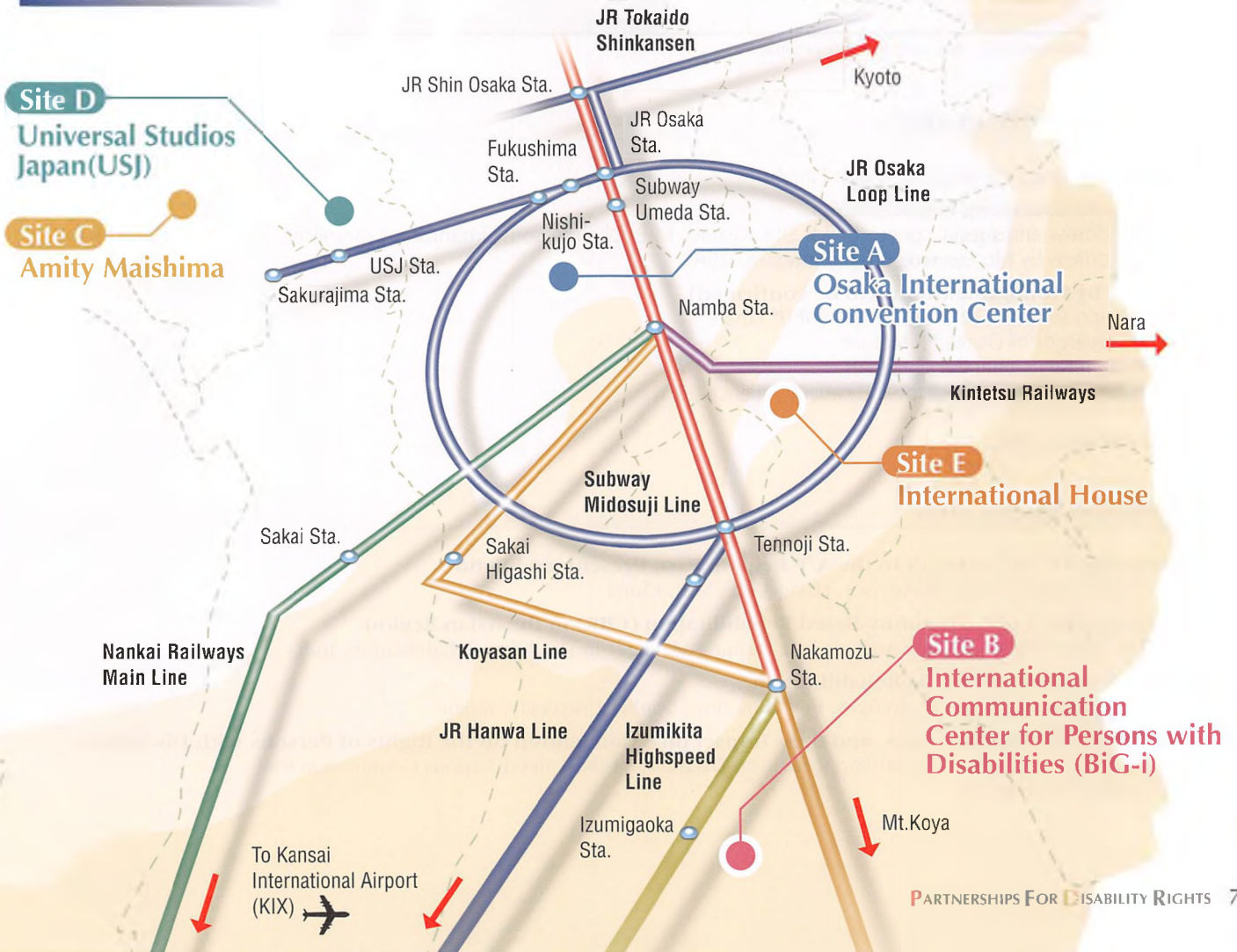

Travel Information

Osaka, Your Host City

Osaka, a center of Japanese economy and culture on a par with Tokyo, is the core of the western part of Japan. Together with Kyoto, Nara, and Kobe, Osaka forms the Kansai metropolitan area. Osaka has become a more vital city since the opening of Kansai International Airport in 1994. You will find Osaka driving forward into the 21st century with new developments such as the Osaka International Convention Center, where the Opening Ceremony and the first day's program of the Osaka Forum will be held.

Osaka is a beautiful city, set on water front and surrounded by the blossoms and greenery of parks and gardens. During the conference, participants will be able to enjoy the best of Osaka. Post-conference trips to nearby Kyoto or Nara, both within 1 hour by train from Osaka are also recommended to make your stay in Japan more attractive and memorable.

Climate

The weather in Osaka in October is getting cold, with an average high temperature of 18 °c and average low temperatures of 10°c (50°F). Participants are recommended to bring long-sleeved clothing. The conference sites center and all major hotels are air-conditioned.

Passport and Visa

All travelers entering Japan must have a valid passport. A participant requiring a visa should apply to a Japanese consular office or diplomatic mission in his/her respective country prior to departure. Participants are advised to contact their local travel agencies or airline companies.

Currency

The currency used in Japan is yen (¥). Foreign currency or traveler's checks can be changed to yen at major banks (open 9:00-15:00 Mon-Fri, closed Sat. & Sun.), hotels, or airports. Only Japanese yen is accepted at stores and restaurants.

It is necessary to show your passport when changing traveler's checks.

Bills come in units of 1,000, 2,000, 5,000, and 10,000 yen, and coins in units of 1, 5, 10, 50, 100, and 500 yen. The approximate rate of exchange is 100 yen for U.S. \$0.77 (as of April, 2002).

Traveler's Checks and Credit Cards

Traveler's checks are not as popular in Japan as in some other countries. They are usually accepted only by leading banks and major hotels.

Visa, MasterCard, American Express, and Diners Club cards are widely accepted at hotels, department stores, shops, and restaurants.

Tax and Tipping

There is no custom of individual tipping in Japan. Instead, a service charge will be included in the bill where applicable. A 5% sales tax applies to almost all consumer purchases made in Japan.

Electrical Appliances

Japan operates on 100-110 volts for electrical appliances. The frequency is 60 Hz in western Japan.

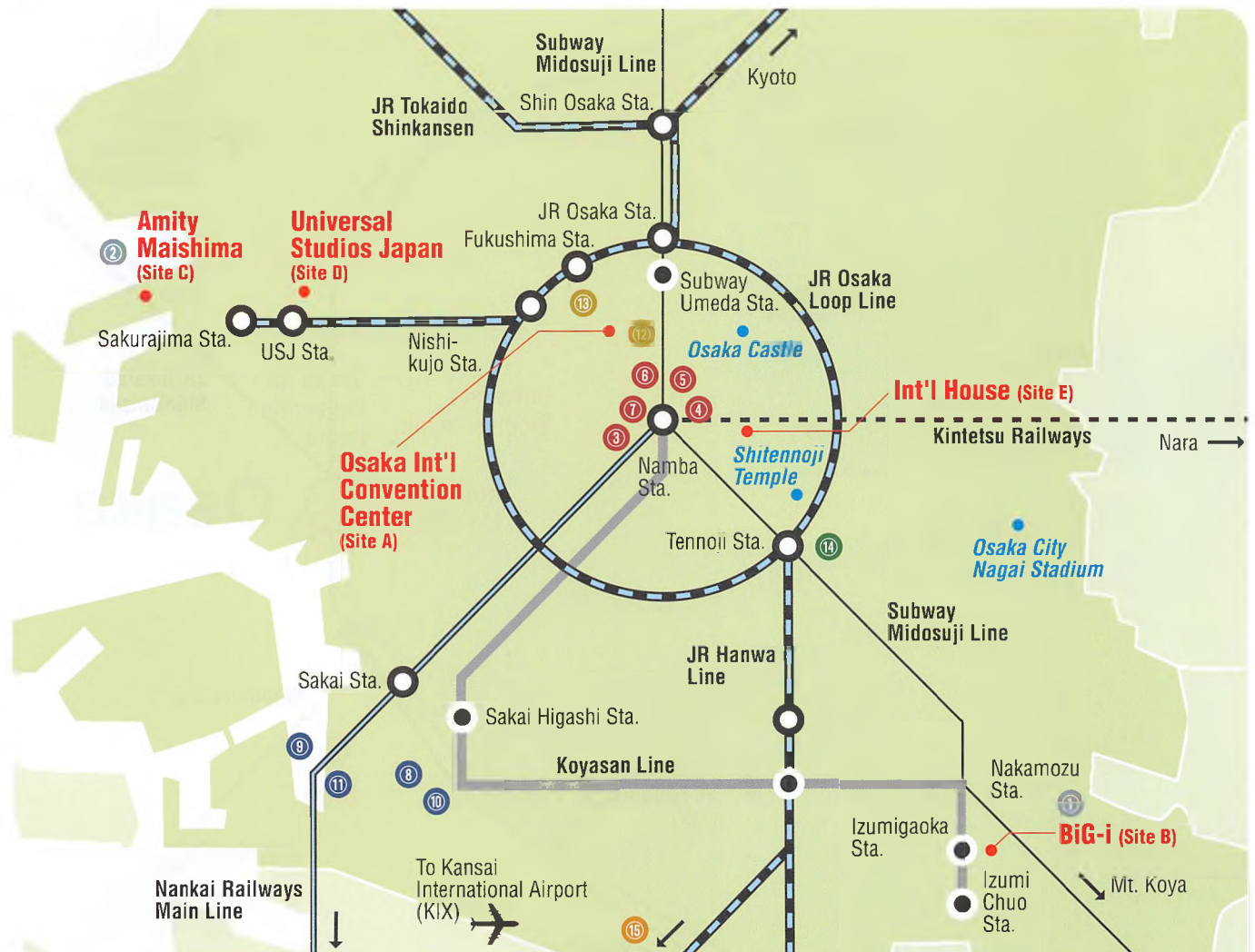
